As your proficiency increases and your training continues, you will have the opportunity to be promoted/ progressed through the Line Mechanic series, ultimately reaching the Hot Stick level (Helper \rightarrow A \rightarrow B \rightarrow C \rightarrow Hot Stick).

Job Responsibilities:

Under direct supervision, in an electric distribution crew, to handle materials, tools and tackle on the ground.

Job Qualifications:

- Should have mental and physical ability to develop into a Line Mechanic.
- Must pass physical abilities examination.
- Must pass validated aptitude test.
- In order to be considered an accredited candidate for a position in the Line Mechanic Job series, candidates must possess, as determined solely by management, (1) a two-year degree or certificate in Electrical Technology, Mechanic Technology or Electric Construction/ Maintenance from an accredited college or university, including a climbing school certificate, or equivalent as determined by management, or (2) a certificate from a recognized OH Line School that includes a climbing certificate.

NOTE: In accordance with the Labor Agreement extension, this position is eligible to be classified as a Day Worker or Scheduled Worker.

NOTE: This will be awarded in accordance with the Accredited Minimum Qualifications MOA dated June 8, 2017.

NOTE: To meet the Job Qualification for the physical abilities examination, the employee must have a sports physical examination to be performed by the Company Nurse or the employee's Health Care Provider. If the employee chooses their own Health Care Provider, Integrated Health Management will provide the Doctor with the prescribed forms.

Please be advised that due to the nature of this position, incumbents are subject to federal Drug & Alcohol safety regulations governing US Department of Transportation ("DOT") covered positions, including the Federal Motor Carrier Safety Administration (FMCSA) and Pipeline Hazardous Material Safety Administration (PHMSA).
