- Large gas meter investigations/set point modifications.
- Regulation station investigations.
- Assist in training employees in a lower classification.
- Completion of field related records/forms.

- Gas regulating station (equipment, set points, configurations).
- Pipelines (both transmission and distribution).
- Large gas meters (proper meter and regulator sizing, delivery pressure requirements, troubleshooting).
- Thorough understanding of pressure systems (MAOPs, interconnections, HiLo valves, regulator set points) including necessary valving, start-up and shutdown procedures, troubleshooting problems.

- Must have thorough knowledge of pressure systems (MAOPs, interconnections, H1Lo valves, regulator set points) including necessary valving, start-up and shutdown procedures, troubleshooting problems.
- Must have class A CDL (Commercial Drivers License).
- Must have basic knowledge of instruments (Heise, etc.).
